WHEREAS, the Board of Directors of APV seeks to ensure the continued cleanliness of the properties subject to the Declaration; and

WHEREAS, APV wishes to clarify the restrictions. and

WHEREAS, Pursuant to Section 5 of the Declaration, the Board of Directors, by majority vote of the entire board, may amend the Declaration.

NOW, THEREFORE, it is hereby resolved by the Board of Directors of APV, as follows:

- 1) The forgoing recitals are true and incorporated herein.
- 2) Section 13.1 of the Poinciana Subdivision Declaration is amended as follows:
- 13.1 Garbage and Trash. No trash, garbage, construction debris or other waste material or refuse shall be placed or stored on any part of the property except in covered or sealed containers approved by the DCB. After construction is complete on a lot, all all such containers must be stored within each residence or concealed by means of a wall or enclosure approved by the DCB.

WHEREAS, Pursuant to Section 5 of the Declaration, the Board of Directors, by majority vote of the entire board, may amend the Declaration.

NOW, THEREFORE, it is hereby resolved by the Board of Directors of APV, as follows:

- 1) The forgoing recitals are true and incorporated herein.
- 2) The first paragraph of Section 6.3 of the Poinciana Subdivision Declaration is amended as follows:

In particular, any construction, alteration, er other work done or failure to perform required maintenance or cleaning in violation of this Declaration, any rules and regulations, the Criteria or Guidelines is subject to enforcement action. Upon written request from the APV or Declarant, Owners shall, at their own cost and expense and within a reasonable time frame identified in the request, cure the violation or restore the Lot and/or home on such Lot to substantially the same condition as existed before the violation occurred. Should an Owner fail to cure the problem or otherwise restore the property as required, the APV, Declarant, or their designees shall have the right, but not the obligation to enter the Lot, remove the violation, and restore the Lot. All costs, together with the interest at the rate the maximum rate then allowed by Florida law, may be assessed against the Lot and collected in accordance with Section 9.4.2 of this Declaration.
